

## Abstract

This short ebook presents a one-page handout that has been distributed for public awareness of 9-11 and DrJudyWood.com. It shows an aerial view of the World Trade Center on the afternoon of 9-11. 


Figure 3. Einstein quote. “The world is a dangerous place to live; not because of the people who are evil, but because of the people who don't do anything about it”




Figure 4. ISBN number for this ebook
